• Interphex 2017, USA

In association and support with IPMMA, FICCI has organised 2nd eddition INDIA Pavilion at Interphex 2017 from March 21st – 23rd, 2017 at New York, USA, under the aegis of Market Access Initiative Scheme of Ministry of Commerce and Industry, GOI.

India participates in INTERPHEX 2017 for the second time, with 52 Indian companies, ranging from equipment manufacturing to packaging.

Indian Participation at this premier event dedicated to pharmaceutical, biotechnology innovation, technology and knowledge. The Indian pharma machinery industry is projected to reach USD 1.8 bn in revenues by 2020, growing at 14% CAGR in last few years. Two key factors attributable for the growth of this sector are capacity addition for the generics production in the country and sales to newer export markets.

India currently exports pharmaceutical machinery and equipment to over 80 countries globally. Exports are estimated to contribute ~35% to the industry turnover. The Indian manufactures have a high cost advantage when compared to other pharma machinery hubs such as those based in Germany.

The Indian pharma industry is expected to reach USD 55 b by 2020.

MSME Registration

Information on MSME was circulated to all the members about its classification, benefits and registration procedure for the benefits of our IPMMA members.

Benefit of MSME Registration

The registration scheme has no statutory basis. Units would normally get registered to avail some benefits, incentives or support given either by the Central or State Govt. The regime of incentives offered by the Centre generally contains the following: - Credit prescription (Priority sector lending), differential rates of interest etc. - Excise Exemption Scheme - Exemption under Direct Tax Laws. - Statutory support such as reservation and the Interest on Delayed Payments Act. (It is to be noted that the Banking Laws, Excise Law and the Direct Taxes Law have incorporated the word MSME in their exemption notifications. States/UTs have their own package of facilities and incentives for small scale. They relate to development of industrial estates, tax subsidies, power tariff subsidies, capital investment subsidies and other support. Both the Centre and the State, whether under law or otherwise, target their incentives and support packages generally to units registered with them.
